SUBJECT: Mutual Agreement for cross-listing HIST 3570 and WGSS 3570

The WGSS program and the History department have a successful history of cross-listing their courses. The mutual agreement for the cross-listing of HIST/WGSS 3570 is as follows.

Allocation of course teaching

Each department will offer two sets of cross-listed sections of HIST/WGSS 3570 in the fall and spring semesters. In the event that one department cannot offer two sections in a semester, there will be consultation between the departments regarding how to achieve parity in FTES.

Staffing

The staffing of the course will be determined on an annual basis by the Director of WGSS and Chair of HIST. Priority in assignment will be given to tenured and tenure-track faculty with expertise in the field, but qualified lecturers with terminal degrees may also be assigned to teach the course.

Sharing of FTES

It is mutually agreed that FTES for cross-listed offerings of HIST/WGSS 3570 shall be split evenly with 75% of seats (and FTES) assigned to the primary department and 25% of seats (and FTES) assigned to the non-primary department.

Summer session

Departments will have the opportunity to each offer one section of the course during the summer session. The department that offers a summer course through PAGE shall list it with only its prefix, and will receive all cost recovery funds generated from that section.

Memorandum of Understanding (MOU)

DATE: September 28, 2021


SUBJECT: CS/CIS 1200

This memo describes the mutual agreement between the department of Computer Science (CS) at the College of Engineering, Computer Science and Technology (ECST), and the department of Information Systems (IS) at the College of Business and Economics (CBE) for the cross-listed courses: CS 1200 Living in a Technology-Based World and CIS 1200 Information and Technology Literacy. CS 1200 is a non-major course for the CS program, being offered for non-CS students in the ECST. It is a required course for the Graphic Communications (GC) program of the Technology department. CIS 1200 is a required course for the Computer Information Systems (CIS) program.

CS 1200 and CIS1200 courses have been cross-listed since Fall 2015. This cross-listing has allowed both ECST (in particular GC) students and CIS students to take either course flexibly and meet their requirement. The department/program which offers the course will be responsible for staffing the course and will receive the FTEs.
